### **Crew Member Attestation – Entry Requirements in Singapore**

*I acknowledge the company has informed me that to join a ship as a crew member in Singapore I must follow the guidance that is listed below.*

*Due to the incubation period of COVID-19, signing-on crew is required to observe a 14-day quarantine period with the following measures in place, prior to being PCR tested for COVID-19:*

- 1. The crew member should remain in his/her place of residence at all times during the isolation period.*
- 2. The crew member should not leave his/her place of residence at all times, even if it is to purchase food and essentials. If necessary, the crew may opt for home delivery services or enlist the assistance of others for his/her daily necessities. **The only acceptable exception to this self-quarantine period will be to visit a local medical facility to comply with the required COVID-19 PCR testing.***
- 3. The crew member should avoid interaction with household members.*
- 4. If sharing a house with others, the crew member should stay isolated in his/her own room and with a dedicated toilet.*
- 5. The crew member should monitor his/her health closely, i.e. twice daily for fever (i.e.  $\geq 38^{\circ}\text{C}$ ) and respiratory symptoms such as cough and breathlessness. The crew member shall maintain a temperature log, which may be provided to relevant authorities upon completion of the isolation period.*
- 6. Should there be any delays in departure flight, the crew member should continue to serve his/her isolation until he/she departs his/her country.*
- 7. During the self-quarantine period, representatives of Royal Caribbean Group may reach out to the Crew Member via video conferencing to monitor the correct compliance with the self-quarantine protocol contained in this document.*

### **Signing-on Crew: Transfer arrangement for medical purposes during isolation**

- 1. The crew member should be transferred directly between the place of residence and medical clinic. There shall be no detour or stopovers in the transfer.*

2. *Public transport should not be used for this transfer. Invoices or receipts for private hired vehicle(s) can be used to show that the crew member concerned has not been exposed to the public.*
3. *The crew member should wear a face mask always and observe social distancing.*

**Signing-on Crew: COVID-19 PCR test and Fit to Travel test**

1. *PCR test should be drawn not more than 72 hours prior to the crew member's departure flight. Laboratory reports for the PCR test need to indicate the sample drawn date and time.*
2. *The crew member should be medically certified to be fit-for-travel by a medical doctor prior to flight departure.*

**Signing-on Crew: Transfer arrangements for flight departure**

1. *The crew member should be transferred directly between the place of residence and the point of departure. There shall be no detour or stopovers in the journey.*
2. *Public transport shall not be used for the transfer. Invoices or receipts for private hired vehicle(s) can be used to show that the crew member concerned has not been exposed to the public.*
3. *The crew member should wear a face mask always and observe social distancing.*

*By signing this attestation, I agree to strictly follow the requirements listed above, and I will immediately inform the company if I have not complied so my travel arrangements can be cancelled.*
